Their Lordships humbly offer their Opinion to His Majesty that Order may be given that both Partys be sent back to Connecticut, to Examine such Witnesses as they can Produce in the said Cause respectively, and that the Examination be regularly taken in such manner as that they may Interchangeably Examine the said Witnesses without any Lett or Molestation whatsoever, by the Governor and Magistrates of that Colony, or any other whom it may concerne, and that such Examinations as shall be taken in this Case in Connecticut be transmitted to this Board under the Seal of the Colony, the whole Proceeding to be at the Cost and Charges of the Respondents, it appearing to the Committee, that the Appellant has been greatly delayed in the Prosecution of his said Appeal, by the Proceedings and at the
