The cases given arel:-By an Act Passed in the Generall Assembly of the Province of Mariland the 10th of June 1697, Stephen Francis an Italian and George Hacombe a German were naturalized, and thereby vested with all the Rights and Priviledges of naturall born Subjects of that Province; and that by an other Act Passed in the same Assembly the 31th of March 1698, one Peter Dondee a Frenchman was in like manner Naturalized, but in both the said Acts, there is an express Provisoe, that they shall not be Construed to enable or qualify the said Persons, to hold or enjoy any Place, office calling or Employment, Prohibited by an Act of Parliament, made in the 7th and 8th years of your Majestys Reigne, for preventing Frauds and Regulating abuses in the Plantation Trade, or any other Statute Law of England. And Wee likewise find that in November 1697, Col. Benjamin Fletcher then Governor of the Province of New Yorke, did Grant Letters of Denization, under the Seal of the said Province, unto one Arnold Nodine a foreiner, in which Grant, there is a Clause to Enable the said Nodine, to take and hold Lands, Tenements, Heroditaments, etc., to himself, his heires and assignes in ffee Simple, with Power to sue and be sued, and to Enjoy all other Rights and Priviledges as a naturall Borne Subject of that Province, without any Restriction or regard to the said Act of Navigation or any other Statute of England; but Wee do not find that the said Col. Fletcher had any Express Power by his Commission to Grant any Letters of Denization. [pp. 410-11.]
