of the Towne, Certifying that she was English Built and belonged to His Majestys Subjects, and altho the Master of the said Ship had by His Petition to the Governor prayed that he might be permitted to Depart the Island without Breaking Bulk, or to Trade there, giving Security to procure a Register in Convenient time. [On security being given, the Council agree to hear the appeal the first Council day in June.]

Memorandum. That the said Thomas Symcocks and Daniel Alford of London Merchants did enter into Bond of Five hundred Pounds, to prosecute the Appeal according to the above Order, the 24th day of September, 1701. [p. 256.]
