The Lords of the Committee Observing that in the aforementioned Draughts of General Instructions to both the said Governors an Alteration is made pursuant to the Opinion of the Lords of the Admiralty in the Description of the Ensign required to be worn by Ships having Letters of Marque and Reprizal And the Lords of the Committee being of Opinion that all His Majestys Governors should be Instructed alike upon this head in Order to prevent any Mistakes that may otherwise arise from Ships not wearing the same Ensign did therefore recommend it to the said Lords Commissioners to consider of and prepare Draughts of Additional Instructions for this purpose in Order to be transmitted to such Governors as may not have already received Instructions thereupon And to lay the same before Your Excellencys for Your Approbation.
